**SUBJECT :** TEMPORARY GUIDELINES DURING THE STATE OF PUBLIC HEALTH EMERGENCY

In line with the Proclamation No. 922 in re: *Declaring a State of Public Health Emergency throughout the Philippines*, in connection with the Corona Virus Disease (COVID-19) and relative to the Executive Order No. 20-009<sup>1</sup> of the Province of Surigao del Norte, **all** required document submission/s concerning any application/s and/or reportorial obligation/s pursuant to the Department of Environment and Natural Resources Administrative Order (DAO) No. 2010-21<sup>2</sup> and other existing mining laws and policy/ies shall be submitted **through the official email address** of Mines and Geosciences Bureau (MGB) Regional Office (RO) No. XIII – [info@mgb13.ph](mailto:info@mgb13.ph). *Provided*, that the **original hard copies** of the said required submissions shall be submitted through postal registry and/or to the MGB RO No. XIII after the Proclamation No. 922 and other issued Executive Orders relative to COVID-19 are lifted.

Further, **payment of any obligation/s** due to MGB RO No. XIII shall be paid in Manager's Check or Postal Money Order payable to **"Treasurer of the Philippines for the account of MGB RO XIII"** pursuant to DAO No. 2005-08<sup>3</sup>.
