On 29 March 2022, MGB RO No. XIII sent a letter to OPCR, informing on the 17 November 2021 Memorandum of MGB CO. In the same letter, we informed that we are ready to issue OP covering only the cleared area of 1,053.00 hectares (13 blocks). On 21 December 21, 2022, this Office approved the issuance of the EP of OPGRC covering 1,053.00 hectares. Thus, sending four (4) copies of the EP for acceptance, signature, and notarization. On 17 July 2023, OPGRC requested an extension to register the EP and pay the occupation fees because they are still negotiating with Dopester in consideration that the area is included to the agreement executed between OPGRC and Dopester.
