(2) Submission of Authenticated Receipt from the Buyer is required only for all Mineral Ore Export Permit holders pursuant to the Department Environment and Natural Resources Administrative Order No. 2008-20.

(3) Oriental Synergy Mining Corporation was allowed to shipped out nickeliferous ore under MPSA No. 011-92-X (SMR) pursuant to the Memorandum dated May 10, 2022 of the Mines and Geosciences Bureau Director, Atty. Wilfredo G. Moncano.

(4) Taganito HPAL Nickel Corporation's tenement location at the Taganito, Claver, Surigao del Norte is within the Surigao Mineral Reservation Area however, it is also within the Taganito-Special Economic Zone which is a Philippine Economic Zone Authority - registered Ecozone Export Enterprise with Certification No. 2023-0842. Thus, it is exempted from the 5% Royalty of Minerals/Mineral Products, 4% Excise Tax, and 1% IP Royalty Share.
